CO-CURRICULAR INITIATIVES

Dr. B.R. Ambedkar Legal Aid Clinic: The Legal Aid Clinic at Xavier Law School aims to connect law with the community by providing free legal aid to underprivileged sections, promoting legal literacy, and offering client counselling. It fosters socially responsible lawyering through practical exposure, student-led initiatives, and faculty support. The Clinic also conducts training workshops, legal awareness camps, and research on socio-legal issues, empowering both students and the community.

Moot Court Society: The Moot Court Society at Xavier Law School manages all mooting activities, including the XLS IntraMoot Court Competition and the Xavier National Moot Court Competition. It also organizes virtual training sessions and encourages student participation in state and national moot court competitions.
